Shelly Doty, City Secretary stated that this meeting of the governing body of the City of Cleburne shall serve as the official canvass of votes for the General Election held May 8, 2010, to elect a Mayor. Mayor Reynolds shall appoint two (2) Councilmembers and the City Secretary to review election returns submitted by the Precinct Judges for discrepancies. The Authority will then adjourn to the Conference Room for their review and report back to the Council with their determination.

Mayor Reynolds appointed Council members Sturgeon and White to serve as the Canvassing Authority. The City Secretary and Canvassing Authority adjourned to the Council Conference for their review.
